Step Forward Michigan offers help to struggling homeowners

Financial troubles can strike unexpectedly. A surprise expense, sudden job loss, or medical emergency can make it hard for a family to pay the mortgage, property taxes, or condominium fees.

Fortunately, the Step Forward Michigan program can help homeowners stay in their homes by allotting folks the money they need to get current on their property taxes, mortgage, or condominium fee payments. That helps homeowners and their communities, which stay stronger with fewer foreclosed homes.

The U.S Department of Treasury created the Hardest Hit Fund in 2010 to provide aid to states that were hardest hit by the financial meltdown and housing market crash. Michigan received more than \$761 million in federal funds to provide assistance for struggling homeowners. To date, more than 32,000 homeowners statewide have

received assistance from the program. In Eaton County, more than 40 families have received over \$300,000 since 2013. More than \$40 million is still available.

The Step Forward Michigan program provides interest free loans of up to \$30,000 to help homeowners catch up on delinquent property taxes, mortgage payments and condominium association fees. The loans are forgivable at 20 percent each year, as long as the property remains the homeowner's primary residence. The loan is forgiven if the homeowner remains in the home after five years.

To qualify for assistance, residents must have experienced an involuntary hardship that caused the de-

linquency and have enough income to cover their future mortgage and property tax payments once caught up. Step Forward Michigan has been instrumental in helping Eaton County residents get back on their feet and keep their homes. Help is just a mouse click or a phone call away

There were a variety of vendors available to speak to veterans. The services represented included, housing, health care, education, employment and many more. Veterans had an opportunity to network with other veterans, pick up surplus provided by the VA and talk to agencies that provide essential services.

The event was organized by Housing Services Mid Michigan in cooperation with the American Legion (Post 42 in Charlotte) and the VA.

"We are so pleased with the turn out from vendors and veterans," said Denise Dunn, Director of Housing Services Mid Michigan. "We just were not sure how many Veterans would show up, and we couldn't be happier with the participation."

The event was highlighted by a special ceremony to recognize our veterans that featured Tim Lewis, Mayor of Charlotte, Representative Brett Roberts from the 65th district, Representative Tom Barrett form the 71st district, Matt Newman from the VA and Lt. Larry Treadwell from the Eaton County Sheriff's Office.

HSMM would like to thank our many volunteers that helped during the event as well as the organizations that supported the event; Kroger, Fay's Willow Tree Cafe and Bakery in Olivet, The Veterans Service Office in Eaton County, American Legion Post 42 and the VA.

The original Stand Down for homeless veterans was modeled after the Stand Down concept used during the Vietnam War to provide a safe retreat for units returning from combat operations. At secure base camp areas, troops were able to take care of personal hygiene, get clean uniforms, enjoy warm meals,

receive medical and dental care, mail and receive letters, and enjoy the camaraderie of friends in a safe environment. Stand Down afforded battle-weary soldiers the opportunity to renew their spirit, health and overall sense of well-being.

Housing Services Mid Michigan is a 501(3) organization dedicated to serving the homeless with programs that reach into Barry, Clinton and Eaton counties. Because of the generosity of our community, our agency was able to assist 1849 individuals, including 1110 adults with 782 children in 2015. To resolve these housing crises, the agency dispersed over \$880,000 in direct financial assistance. As a non-profit, donations may be tax-deductible.


