A LETTER FROM THE DIRECTOR

Dear Friends and Supporters,

2023 was a year with transitions and new beginnings. Housing Services was able to roll out two new programs to assist those facing homelessness. In Clinton County, Housing Services Mid Michigan (HSMM) took over a Rapid-rehousing Program in October. This program provides rental assistance and case management to those who are literally homeless in Clinton County. The program is designed to assist those with higher needs that need longer term assistance than first month's rent. The second grant allowed HSMM to hire a Housing Navigator. This position can assist with housing search assistance and landlord coordination for those struggling to obtain safe and affordable housing. These new additions were a great benefit to our communities.

Additionally, HSMM's Housing Counseling Program received funding from the Eaton County Treasurer's office. This allowed us to expand our foreclosure prevention services to more households that may be in danger of losing their homes. Also, our Assistant Director put in the work to became a HUD-Certified Housing Counselor and can now provide back-up coverage for our staff members.

The effects of the pandemic still impacted our community's financial stability. Housing continued to be extremely difficult to locate and the price of rent increased with the demand. This lack of housing caused the number of homeless individuals living on the streets and in their cars to increase. Annually, we are required to count the homeless population on a single day in January, called PIT (Point in Time). For many years, the PIT number of street/unsheltered homeless individuals remained very low at 0 to 5. However, in January 2023 the count showed the number of unsheltered individuals increased in Eaton County to 13 and in Clinton County to 4. This alarming trend and the continuing affordable housing shortage became our focus in conversations. I participated in an action teams that improved landlord engagement in Eaton County and advocated for emergency shelter in Clinton County.

2023 marked my 20th Anniversary with the agency. I am so proud of the work we have accomplished. In thinking back to 2003, I had no idea that this small non-profit would double in size and that its success would become my life's mission. Becoming the Executive Director and being able to learn so much has become the best accomplishment of my life. I want to thank all the staff and Board over the years for all their support and commitment. It takes a strong team to be able to have the successes this agency has had and I am very grateful to be apart of it.

This year marked another milestone for the project. Both the Clinton County and Eaton County events saw an impressive turnout of dozens of community partner agencies, each offering their unique resources and support. Attendees benefited from a variety of free services, including site immunizations, haircuts, and personal need items. We look forward to attending again in November of 2024.



HSMM DATA

In 2023, HSMM provided case management for 1123 adults and 861 children and assisted a total of 988 households. This assistance was provided throughout the Tri-County Area and included:
